UPON hearing the counsel the Court made the following
O R D E R

1. Mr. Gopal Subramaniam, learned Senior Counsel for respondent No.5, at the outset, states that respondent No.5-builder is ready and willing to accept the prayer made by the petitioner before the High Court, which find mention in para 4 of the impugned judgment dated 31.01.2025, namely, to provide him an access through internal chak road, which passes along the northern boundary of his Plot No.33.
2. Learned state counsel points out that the direction issued by this Court vide order dated 27.05.2025 to maintain *status quo* is sought to be misconstrued as if the private respondent is also not permitted to continue with the development activities at its own site.
3. Consequently, we clarify the order dated 27.05.2025 to the effect that *status quo* shall be maintained only *qua* the land owned by the petitioner. The State or respondent No.5 shall be at liberty to continue with their development activities.
4. At the request of learned Senior Counsel for the petitioner, post the matter for hearing on 14.08.2025.
